## **2Q14 Hightlights**

- Leasing revenue totaled R\$65.2 million in 2Q14, 5.3% up on the R\$61.9 million recorded in 2Q13.
- In 2Q14, FFO came to **R\$64.0 million** (R\$3.33/share), 24.3% more than the R\$51.5 million (R\$2.68/share) posted in the same period last year. Adjusted FFO stood at **R\$65.1 million** (R\$3.38/share).
- In May, CB Richard Ellis concluded the half-yearly appraisal of the portfolio's assets, which resulted in a negative impact of R\$65.1 million on the value of the properties.
- Second-quarter net loss amounted to -R\$0.7 million (-R\$0.04/share).
  Excluding the effects of portfolio appraisal, the net income came to R\$64.4 million, which was a 35.7% increase on the R\$47.4 million recorded during the same period of the previous year.
- Shareholders' equity closed 2Q14 at **R\$3.2 billion** (R\$166.42/share), 1.8% down on 1Q14 due to asset revaluation concluded in May.
- Earnings distributed in 2Q14 came to **R\$3.03/share** (R\$58.3 million), 5.2% up on the **R\$2.88/share** (R\$55.4 million) recorded in 2Q13.
- In the last 12 and 24 months (base of June/2014) shareholder profitability (considering earnings distributed and fund share price appreciation) totaled -2.9% and -6.5% respectively.
- At the end of 2Q14, portfolio GLA stood at 302,041 m<sup>2</sup>, in line with 1Q14.
- Financial vacancy stood at 14.0% at the end of the quarter, compared to 10.8% at the end of 1Q14, due to the vacant areas in Flamengo Park Tower and Brazilian Financial Center.
- In 2Q14, 3.5% of the contract portfolio, in terms of revenue contracted at the beginning of the period, entered into negotiation period or came from new leases and there was no variation in lease amounts in real terms.
